Resolution 1 (2014)

**Adopted by the Human Rights Council at its
1st meeting, on 10 April 2014**

The Human Rights Council,

Reaffirming 1951 Convention relating to the Status of Refugees,

Concerned by forced demographic changes resulting from the conflicts in the world,

Recognizing the particular vulnerability of women and children among refugees and other persons of concern, including exposure to discrimination and sexual and physical abuse, and in this regard acknowledging the importance of preventing and responding to sexual and gender-based violence,

Gravely concerned about the rising number of refugees in various parts of the world,

Acknowledging the efforts of Member States, the United Nations High Commissioner for Refugees and other stakeholders in improving the situation of refugees, and expressing grave concern about the deteriorating living conditions in many refugee camps,

Recognizing that hosting States have the primary responsibility for the protection of and assistance to refugees on their territory, and the need to redouble efforts to develop and implement comprehensive durable solution strategies, in appropriate cooperation with the international community, and burden- and responsibility-sharing,

1. *Strongly urges* governments to fight with any display of discrimination towards refugees and pursue a social policy combating intolerance among their citizens,
2. *Affirms* that the refugees will be able to enjoy all fundamental rights and freedoms according to the Universal Declaration of Human Rights as nationals of the countries and will be supported in realization of these rights,
3. *Calls upon* the countries and the UNHCR in collaboration with other actors to take appropriate measures to create harmonious relationships between refugees and local communities, as well as promoting among refugees respect for the local culture, customs and religions,
4. *Proposes* to raise extra voluntary funds by organizing charitable cultural performances which represent cultural traditions and customs of refugees from different countries,
5. *Supports* the creation of world refugees community in order to establish the relations between refugees around the world on regular basis,
6. *Strongly urges* the countries to pay attention to the school education of children in refugees' camps by:
 - supporting and contributing to the establishment of new schools,
 - providing all the children with education as one of the basic rights of the individuals according to the Universal Declaration of Human Rights,
7. *Suggests* coordinating and encouraging financial support by any willing actor to the work of non-governmental organizations all over the world which deal with promotion of the Human Rights of refugees,
8. *Suggests* creating a temporary camp for refugees in Siberian region where they can work and live freely on the same conditions as other foreigners in the Russian Federation and Russian citizens and can help Russian Federation to develop this part of country and to allow other governments to transfer refugees if there is no extra forces to provide refugees with necessary shelter,

9. *Suggests* authorizing the UNHCR to spread social advertisement in possible countries of escape, to provide all people at the risk of persecution with necessary information about ways of saving their lives and receiving help.
