Resolution 4 (2016)

Adopted by the Security Council at its 4th meeting on 1 April 2016

The Security Council,

Acting under Chapter VII of the Charter of the United Nations,

Reaffirming that migrants, including asylum-seekers and refugees, regardless of their migration status, should be provided with humanity and dignity and that their rights should be fully respected,

Realizing the necessity to protect completely the human rights and fundamental freedoms of all migrants, regardless of their migration status, especially those of women and children.

Welcoming support already provided by the most concerned Member States, including Member States of the European Union (EU), taking into account the role of FRONTEX.

Expressing solid support to the States in the region troubled by the illegal trafficking of migrants,

Emphasizing the need to intensify coordination of efforts in order to strengthen an efficient complex response to these common challenges in the manner of international solidarity and shared responsibility, to deal with their roots and to prevent people from being exploited by migrant smugglers and human traffickers,

- 1. *Invites* all the Member-States of the UN to join and work closely with the United Nations High Commissioner for Refugees (UNHCR), the agency with the mandate to protect refugees and stateless people and the technical expertise on refugee status determination, in particular to strengthen the admission and assessment procedures following the recommended procedures of UNHCR,
- 2. *Calls* all governments to provide full support to the most problematic sections of refugee crisis, including:
- a. to finance building shelters; provide additional stuff and social workers for assistance; provide food, water, clothing and medicine in temporary refugee camps in the EU, in the Middle East, and in Turkey,
- b. to finance and provide equipment and staff for border control to those the EU countries that are in the dire need,

- c. to finance and provide equipment and stuff for the EU coastguard service in the Mediterranean and Black sea,
- 3. *Proposes* rules of stay of refugees on the EU territory with next demands which are applicable only to refugees fleeing from war:
 - a. limitation the time of stay until 3 years with possibility of prolongation;
- b. strengthening military presence at the places of mass influx of people in order to contribute to good border management and prevention of illegal crossing the borders;
- c. contribution to the employment of refugees in accordance with their professional and educational level,
- 4. *Encourages* all states affected by the refugee crisis to run educational and cultural programs devoted to the proliferation of tolerance and cultural awareness,
- 5. *Recommends* creating economic zones in the places of refugee settlement in order to contribute to their social and economic inclusion and development,
- 6. *Calls* authorized Special UN Agencies to assist Turkey to take control over their border,
- 7. *Decides* to submit the problem of Syria conflict to the next session of the Security Council and to propose the General Assembly and all authorities interested in the solution to discuss it on sessions of the General Assembly.
 - 8. *Decides* to remain actively seized of the matter.
